- 2. Scope of Licence: Subject to your compliance with this Licence Agreement, we grant to you a limited, non-transferrable, revocable Licence to use the CommBank Small Business App on any compatible device that you own or control and as permitted by the applicable Google Play terms and conditions of use (the "Usage Rules"). You may not rent, lease, lend, sell, redistribute or sublicence the CommBank Small Business App. You may not copy, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the CommBank Small Business App, any updates, or any part thereof.
