



Grain markets firm as Argentine crop stress rises...

- Markets:** European shares were weaker on Friday as investors grew nervous about the possibility of further ratings downgrades in Europe. Fitch placed Belgium, France, Cyprus, Ireland, Italy, Slovenia and Spain on credit watch and warned that a comprehensive solution to the debt crisis is "technically and politically beyond reach". US shares gave back early gains on Friday as the ongoing European debt crisis outshone the upbeat US economic data US consumer prices were flat in November after a 0.1% drop in October. Consumer prices were up 3.4% in the 12 months to November. Excluding food and energy consumer prices was up just 0.2% in November.
- Currencies:** The AUD ended slightly firmer at USD0.9951 on Friday night (London close) while the USD index dipped 0.1% to 80.3pts.
- Weather:** A trough is generating warm, humid northerly winds, rain and a few storms in QLD, NSW, eastern VIC and TAS. Cooler westerly winds are affecting western VIC and SA as a high clears the area. A monsoon trough is generating heavy storms in the northern tropics. (www.weatherzone.com.au)
- Grains:** US grain markets finished higher on Friday night.
 - CBOT wheat (Mar 12) rose 0.8% (4½¢) to US\$583.75/bu (–A\$217/t) on Friday night despite the recent improvement in US winter wheat crop conditions and slow export demand for US supplies. Also bearish for prices were reports that Informa has lifted its 2012 US wheat area forecast to 57.07 million, above its November estimate of 57.0 million and well above the 2011 area of 54.4 million. However US winter wheat area may be 813 thousand acres behind last year according to Informa. Supporting wheat prices for the session was the strength in the nearby soybean and corn markets, which in turn were supported by crop stress in Argentina.
 - CBOT corn (Mar 12) firmed 4 cents to US\$583/bu on Friday on the back of summer crop production concerns in Argentina. Bearish for corn prices was the Informa estimate that US corn area will increase to 94.4 million acres, the most since 1944, above Informa's November estimate of 94 million, and above the 2011 corn area of 92 million acres.
 - ASX NSW wheat (Jan 12) finished quoted slightly weaker at \$199.5/t on Friday with WA Jan 12 contract dipped to \$220/t. Feed barley values also fell with the Jan 12 contract closing the week at \$176/t, however sorghum values bucked the trend and closed firmer. Widespread heavy rain fell throughout SA, Vic and southern NSW over the weekend.
- Oilseeds:** CBOT soybeans (Jan 12) rallied 1.6% (18¼¢) to US\$1130/bu because of increasing crop stress in Argentina and dryness in southwest Brazil. Reuters reported that Informa has reduced its estimate of the 2012 US soybean area to 74.6 million acres, down from the November forecast of 76.1 million and the 2011 acreage of 75 million. Increased cotton acreage is expected to trim soybean area according to the report. Canadian canola (Jan 11) rose C\$5.2 to C\$506.3/t.
- Cotton:** The NY cotton futures finished mixed on Friday. The Mar 12 contract finished flat at US\$86.29/lb, the July 12 contract rose 11pts to US\$85.78/lb and longer dated contracts finished lower. Volumes were again thin. The Chinese government has reportedly estimated this year's national cotton crop at 6.5 million tonnes, below the China Cotton Association's forecast of 7.3 million tonnes and Cotlook's 7.15 million tonne forecast. In other news, Informa has raised if 2012 US cotton area forecast by 1.4 million acres to 13.15 million. This year 14.7 million acres of cotton was planted in the US, but only 9.85 million harvested according to the USDA.
- Sugar:** NY raw sugar (Mar 12) rallied 1.5% (33pts) to US\$23.08/lb on Friday, yet there appeared little fresh news to support the gains for the session. Volumes traded slumped to their lowest level since August, a signal that there is little confidence in the near term direction in the sugar market. Activity in the sugar pit is likely to continue to dwindle as we enter the festive season.
- Crude Oil:** NYMEX crude oil (Jan 12) fell 0.4% to USD93.53/bl.

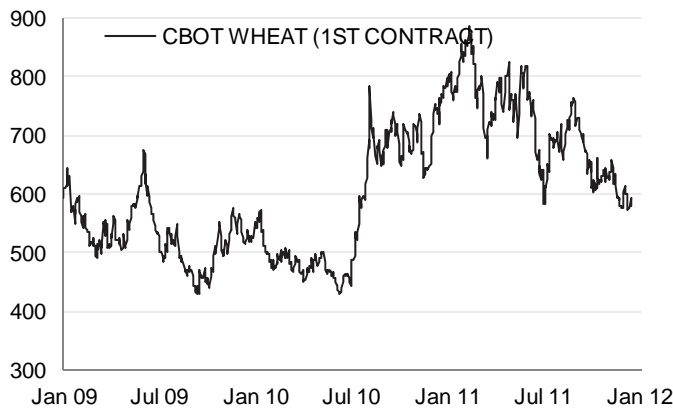


Figure 2: ASX NSW Wheat (Jan 12 Contract, A\$/t)

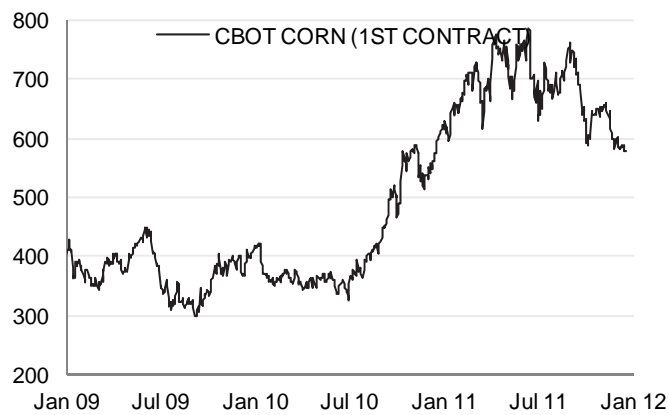


Figure 4: ASX Feed Barley (Jan 12 Contract, A\$/t)
