

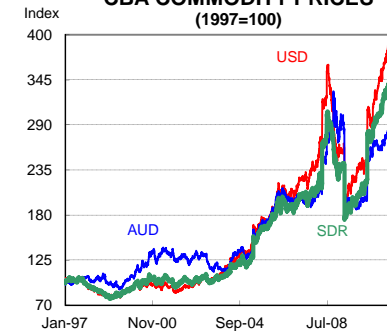

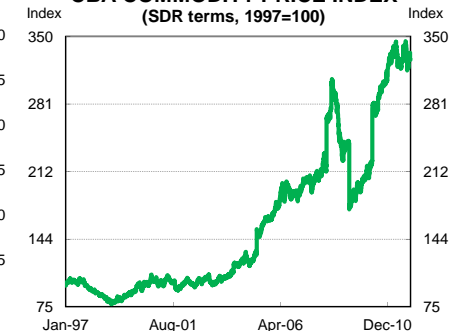

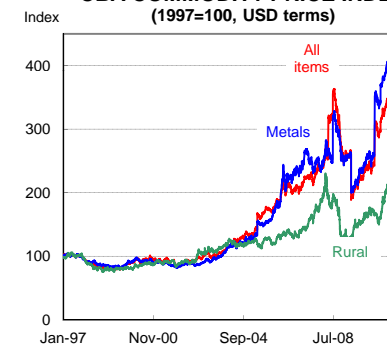
CBA COMMODITY PRICES (1997=100)



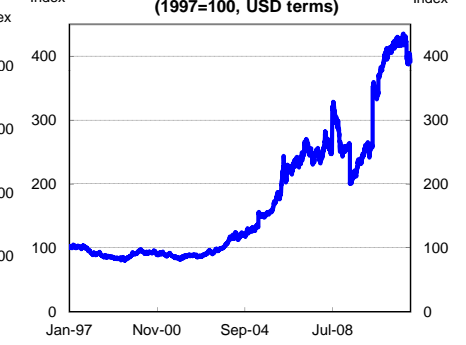
CBA COMMODITY PRICE INDEX (SDR terms, 1997=100)



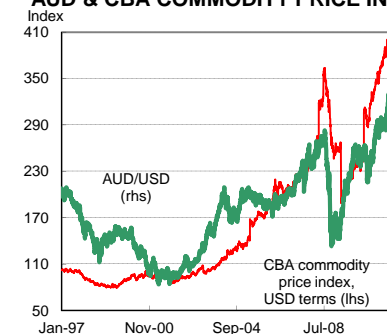
CBA COMMODITY PRICE INDEX (1997=100, USD terms)



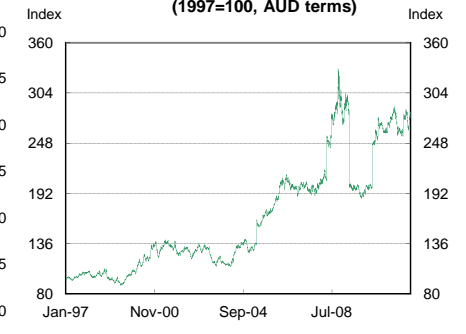
CBA METAL PRICE INDEX (1997=100, USD terms)
