## COMMONWEALTH BANK PERLS V COMMENCEMENT OF TRADING

## Sydney – 13 October 2009:

Commonwealth Bank of Australia (the "**Group**") advises that the timetable for the commencement of Perpetual Exchangeable Resaleable Listed Securities ("**PERLS V**") trading on ASX has been amended.

PERLS V have been quoted on a conditional and deferred settlement trading basis but have not commenced trading. They are now expected to commence trading on a conditional and deferred settlement basis at **11am** (**Sydney time**) on **14 October 2009** under the ASX code of "CBAPA".

There is no change expected to any other dates. The issue date for PERLS V is still expected to be 14 October 2009.

An indicative schedule of the names of the persons expected to be 20 largest PERLS V holders, following issue of PERLS V, and a distribution schedule are attached.

### **Conditional and Deferred Settlement Trading**

Trading in PERLS V will commence on a conditional basis because trading is conditional on settlement under the Offer Management and Subscription Agreement for the offer, the issue of PERLS V and their transfer to successful applicants under the offer. If these conditions are not satisfied within 10 business days after the commencement of conditional and deferred settlement trading in PERLS V:

- PERLS V will not be issued;
- the contracts formed on acceptance of successful applications will be cancelled;
- application monies will be refunded without interest; and
- all conditional trades in PERLS V that have occurred will be cancelled.

Subject to the satisfaction on these conditions, PERLS V are expected to commence trading on a deferred settlement basis on ASX on Thursday 15 October 2009. It is expected that normal trading on ASX will commence on Tuesday 20 October 2009.
