

AFC Women's Asian Cup Australia 2026™ CommBank Mini Mates Competition

Terms and Conditions

1. The Commonwealth Bank of Australia 'AFC Women's Asian Cup Australia 2026™ CommBank Mini Mates Competition' (**Promotion**) is conducted by the Commonwealth Bank of Australia ABN 48 123 123 124 of 1 Harbour Street, Sydney NSW 2000 (PH: 13 2221) (**Promoter**).
2. The Promotion commences at 12:01am (AEDT) on 15th December 2025 and closes at 11:59pm (AEDT) on 4th January 2026 (**Promotion Period**).
3. In these Terms and Conditions:
 - (a) the term 'CommBank Mini Mates Program' means an initiative of the Promoter that offers children the unique opportunity to walk out onto the field with professional players before match kick-off at the AFC Women's Asian Cup Australia 2026™; and
 - (b) the term 'Participating Mini Mates' means the children participating in the CommBank Mini Mates Program.

Eligibility

4. Entry is open to individuals who:
 - (a) reside within Australia;
 - (b) are aged 18 years and over;
 - (c) are able to attend an AFC Women's Asian Cup Australia 2026™ (**Cup**) match in New South Wales, Queensland or Western Australia (**Participating States**) on the date(s) specified by the Promoter (currently anticipated to be between 2nd March 2026 and 14th March 2026 (**Cup Period**), but match dates are subject to change);
 - (d) are involved, as a parent or guardian of a player, with an active Australian football club registered with Football Australia Limited (ABN 28 106 478 068) (**Club**);
 - (e) are involved, as a parent or guardian of a player, with a registered team within their Club that they will nominate to participate in the CommBank Mini Mates Program for this Promotion (**Nominated Team**); and
 - (f) are not persons who are (as determined by the Promoter):
 - (i) involved (whether as a principal, agent or employee) in the conduct or the promotion of the Promotion (including any person who determines who is to win a prize in the Promotion); or
 - (ii) involved in the management of the Promoter or any of the Promoter's related entities or any other benefitting organisation,

(**Eligible Entrants**).

How to enter

5. To enter the Promotion, Eligible Entrants must, during the Promotion Period, complete the entry form for the Promotion available on the Promoter's website at commbank.com.au/minimates, which includes:
- (a) selecting that the Eligible Entrant wishes to enter the Promotion;
 - (b) accepting these Terms and Conditions;
 - (c) selecting the Participating State for which the Eligible Entrant would like to receive Cup match tickets for their Nominated Team (**Preferred State**);
 - (d) nominating their top three preferences for Cup matches they would like to attend with their Nominated Team in their Preferred State from the options available (**Preferred Matches**);
 - (e) providing an unlisted link to a YouTube video featuring a 'fire-up speech' by their child who is in their Nominated Team to players in the Cup (either to the players generally or to specific players or teams) with a maximum length of 30 seconds (**Video**);
 - (f) completing the required fields about their Club and their Nominated Team, including but not limited to their Nominated Team's name and age group;
 - (g) providing the Eligible Entrant's contact details including name, phone number and email address; and
 - (h) acknowledging that the CommBank Mini Mates Program is only open to children aged from 6 to 10 years old for the duration of the Cup Period.
6. Each Eligible Entrant is entitled to enter the Promotion once and is only eligible to receive one Prize (as defined below). For the avoidance of doubt, there will only be one Prize awarded per Club. If a member of the Eligible Entrant's Nominated Team has already won a spot as a Participating Mini Mate through another promotion by the Promoter, they will not be eligible to participate in a Prize for this Promotion.
7. By entering, each entrant agrees to:
- (a) the Promoter's privacy policy available at www.commbank.com.au/privacy (**Privacy Policy**); and
 - (b) these Terms and Conditions.

9. The total Prize pool includes 28 Prizes, across 14 Cup matches, with 2 Prizes awarded per Cup match.
10. The total value of all Prizes in the Promotion is from \$22,820.
11. The Prizes are being provided by the Promoter.
12. The Promoter is not responsible for each Winner's transportation to and from a Cup match, or any ancillary costs. These costs will need to be covered by each Winner as a personal expense.
13. Participating Mini Mates will be provided with food and beverages while they participate in the CommBank Mini Mates Program at a Cup match and will also receive an official CommBank Mini Mates Program uniform which they will be required to wear.

Determining the Winners

14. The Videos submitted by Eligible Entrants will be judged on their creativity and inspiration by a panel consisting of 4 judges from the Promoter (**Judges**) from 5th January 2026 to 13th January 2026 via secure online means (**Judging**).
15. The Judges will:
 - (a) select 28 entries from Eligible Entrants that are judged as being the most creative and inspiring to be the winners (**Winners**) that will be awarded a Prize and a further 28 additional entries from Eligible Entrants to be reserve winners if a Prize is unclaimed or cannot be delivered to or accepted by a Winner in accordance with these Terms and Conditions (**Reserve Winners**); and
 - (b) rank the Winners and Reserve Winners in order from highest to lowest based on the Judging criteria set out in clause 15(a) above.
16. Prizes will be allocated based on each Winner's:
 - (a) judgement ranking in accordance with clause 15(b) above, with higher ranking Winners being prioritised in terms of their Preferred Matches; and
 - (b) Preferred State.
17. Winners are not guaranteed to receive a Prize to one of their Preferred Matches, as this will be determined in accordance with the Winner's judgement ranking in accordance with clauses

15(b) and 16(a) above. However, Winners are guaranteed to receive a Prize in their Preferred State.

18. The selection of Winners and Reserve Winners is final.

Announcing and notifying the Winners

19. The Promoter will notify the Winners by telephone and email by 5:00pm (AEDT) on 16th January 2026.
20. The Promoter will publish each Winner's first initial, last name and state or territory on the Promoter's website at commbank.com.au/minimates by 5:00pm (AEDT) on 21st January 2026.

Claiming the Prize

21. Each Winner must claim their Prize by 5:00pm (AEDT) on 21st January 2026 by confirming receipt of the notification during the notification telephone call, by return email or by such other method specified in the notification email.
22. If a Prize is unclaimed or cannot be delivered to or accepted by a Winner (e.g. due to an invalid entry) by 5:00pm (AEDT) on 21st January 2026:
- (a) the Winner will be taken to have forfeited the Prize and the Promoter will award the Prize instead to a Reserve Winner to have been next selected;
 - (b) the Promoter will notify that Reserve Winner by telephone and email by 5:00pm (AEDT) on 27th January 2026 of the Prize being awarded to it, and will publish their first initial, last name and state or territory in the manner described in clause 20 on the following day; and
 - (c) the Reserve Winner must claim their Prize by 4:00pm (AEDT) on 30th January 2026 by confirming receipt of the notification during the notification telephone call, by return email or by such other method specified in the notification email.
23. If a Reserve Winner does not claim the Prize within the time specified in clause 22(c), the Prize will be forfeited.

Distributing the Prizes

24. Upon each Winner (or Reserve Winner, if applicable) claiming the Prize, the Winner (or Reserve Winner, if applicable) will be contacted by the Promoter to make arrangements regarding the taking of the Prize and organising the next steps.

Conditions of taking a Prize

25. As a condition of taking a Prize, each Winner or Reserve Winner (as the case may be) (**Prize Recipient**) agrees to:
- (a) being contacted for purposes directly related to the Promotion;
 - (b) provide the Promoter with the contact details of each individual who will participate in the Prize (**Prize Participants**). In doing so, the Prize Recipient agrees that they have:

- (i) provided a copy of these Terms and Conditions to each Prize Participant and their parent or guardian and ensured that each Prize Participant and their parent or guardian agrees to these Terms and Conditions; and
 - (ii) obtained the consent of each Prize Participant and each Prize Participant's parent or guardian to share their names and contact details including email address with the Promoter;
 - (c) enter into and comply with, and procure that each Prize Participant enters into and complies with:
 - (i) the terms and conditions that apply to the Cup match tickets included in the Prize;
 - (ii) the conditions of entry imposed by the operators of the venues at which the Cup matches will take place; and
 - (iii) any further agreements or requirements of the Promoter, The Asian Football Confederation (**AFC**) or Local Organising Committee of AFC Women's Asian Cup 2026 Pty Ltd (ACN 681 496 006) (**LOC**) to participate in the CommBank Mini Mates Program (and the Promoter discloses that the AFC requires Participating Mini Mates to be of a height between 115cm and 135cm);
 - (d) the Promoter using their, and each Prize Participant's, first name, Club name, and Video in any media for the purpose of this Promotion (including any outcome);
 - (e) sign, and procure that each Prize Participant and their parent or guardian signs, any legal release and indemnity as may be reasonably required by the Promoter and/or any suppliers of any elements of the Prize;
 - (f) nominate two chaperones to participate in the CommBank Mini Mates Program who are at least 18 years of age, are a parent or guardian of a Participating Mini Mate and will be required to accompany the 11 Participating Mini Mates at the particular Cup match for which the Prize applies (and in doing so, the Prize Recipient agrees that they have the chaperones' consent to nominate them and have referred the chaperones to a copy of these Terms and Conditions); and
 - (g) their details, the Prize Participants' details and, where applicable, the Prize Participants' parents' or guardians' details, including but not limited to name, contact details such as phone number and email address, dietary requirements and accessibility requirements, being disclosed to the AFC and LOC in order to provide the Prize.
26. The Promoter will provide the Prize Recipients and Prize Participants with a copy of the AFC Women's Asian Cup Australia 2026™ Ticket and Entry Conditions with delivery of the Prize tickets, with which they must comply.
27. Only 11 positions per Nominated Team are on offer for each Prize. If a Nominated Team has less than 11 participants or if less than 11 participants can participate in the CommBank Mini Mates Program, its Club may select other team members from the same Club, provided that they are within the required age and height range as set out in clauses 5(h) and 25(c)(iii) above. Any requests for changes in Participating Mini Mates must be made with the Promoter by email to minimates@cba.com.au at least two weeks prior to the Cup match relating to the Prize. If a child can no longer participate in the Prize after that date, they will not be able to redeem or transfer their participation.

28. Tickets as part of the Prizes will be sent by email to each of the successful Prize Recipients and will be non-transferrable.

Resolving disputes

29. Complaints regarding the Promotion may be submitted by:
- (a) completing the online complaints form available at www.commbank.com.au/contactus;
 - (b) calling 13 22 21; or
 - (c) visiting any Commonwealth Bank branch.
30. If there is a dispute concerning the complaint, the decision of the Promoter is final and binding, and no further correspondence will be entered into.

General

31. Information on how to enter the Promotion and Prize details set out in all communications regarding the Promotion form part of these Terms and Conditions.
32. Any entry not complying with these Terms and Conditions is invalid. Errors and omissions may be accepted at the Promoter's discretion.
33. Beneficiaries of the Prize accept the Prize 'as is' and acknowledge that the Promoter accepts no responsibility for any tax implications that may arise from their Prize. Beneficiaries of the Prize should seek advice from the Australian Tax Office or their own taxation adviser or independent financial adviser.
34. The Promoter reserves the right, at any time, in its sole discretion, to verify the validity of entries and entrants (including an entrant's identity, age, place of residence, phone number, email address and proof that their Club is an active and registered football club) and reserves the right, in its sole discretion, to disqualify any entrant whom the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper conduct calculated to jeopardise fair and proper conduct of the Promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
35. If for any reason this Promotion is not capable of running as planned (including but not limited to infection by computer virus, bugs, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Promotion), the Promoter may, subject to the legal requirements of any relevant regulatory authorities, take any action that may be available including cancelling, terminating, modifying or suspending the Promotion.
36. The Prizes are valued in Australian dollars unless expressly stated to the contrary.
37. All Prize amounts in these Terms and Conditions are inclusive of the Australian goods and services tax (GST) unless expressly stated to the contrary.
38. All costs and expenses not specifically mentioned as being included in the Prize are solely the Prize Recipient's and Prize Participants' responsibility, including but not limited to any costs of transport, travel such as flights, transfers, travel insurance, meals and accommodation. The Prize Recipient and Prize Participants take the Prize at their own risk.

39. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010* (Cth), as well as any other implied warranties under the *Australian Securities and Investments Commission Act 2001* (Cth) or similar consumer protection laws in the states and territories of Australia (**Non-Excludable Guarantees**).
40. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and its related entities (including their respective directors, officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in Prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a beneficiary of a Prize (including an Eligible Entrant and the Prize Recipients); (f) use/taking of the Prize; (g) the Promotion.
41. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
42. All entries become the sole property of the Promoter. 43. The Promoter will use and handle entrants' personal information as set out in its Privacy Policy. The Privacy Policy set outs how individuals may access, update or correct their personal information, change their direct marketing preferences or make a privacy complaint.
44. The Promotion and these Terms and Conditions will be governed by the law of New South Wales, Australia, being the state in which the Promoter has its Head Office. Entrants accept the non-exclusive jurisdiction of courts and tribunals of New South Wales in connection with any disputes concerning the Promotion.
