TARGET MARKET SUMMARY

The Fund may be suitable for investors seeking income, diversification and defensive investment characteristics, uncorrelated to other asset classes to be used as a satellite allocation or core component of their portfolio. These investors may have a medium investment timeframe (3 years +), a low to high risk/return profile and be seeking exposure to a defensive asset.
