How do I have my identification certified?

About Your Tax File Number (TFN)

Why can we ask for it? Under super law (Superannuation Industry (Supervision) Act 1993), we can collect, use and disclose your TFN.

How will we use it? If you give us your TFN, you are giving us consent to use it for legal purposes. This includes disclosing your TFN to another super fund, when your benefits are being transferred, unless you request us in writing not to disclose your TFN to any other super provider; and where applicable and unless you opt out, searching for your other super accounts (see below).
