TERMS AND CONDITIONS

- 3. Information on how to enter and the Prize (defined below) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 4. The Promotion commences at 12.00am (AEDT) on 15 December 2025 and closes at 11:59pm (AEDT) on 31 January 2026 ("Promotion Period").

The Promotion is authorised under Australian Capital Territory Permit No. TP 25/02982, New South Wales Authority No. TP/04034 and South Australia License No. T25/2260.

Eligibility

- 5. Entry is open to Australian residents who:
 - a) are a CommBank customer, who holds an active eligible CommBank retail Visa credit card, Travel Money Card, Business Visa debit card and has a Travel Booking profile. Where a Business Visa debit card is used for entry, the entrant will be deemed to be the individual listed on the Business Visa debit card; and
 - b) are over 18 years old; and
 - c) hold a valid phone number and email address with the Commonwealth Bank of Australia ABN 48 123 123 124 (CommBank) and are eligible to receive marketing communications from CommBank at the time of the draw and when the winner is contacted.  - f) are not involved in the management of the Promoter or any of the Promoter's related entities or any other benefitting organisation; and
 - g) are able to take the following components of the Prize (defined below) within the period from 5 March 2026 to 9 March 2026 ("Travel Period"): flights to Melbourne referred to in clause 12(a); accommodation referred to in clause



12(b); tickets to events referred to in clause 12(c); and transfers referred to in clause 12(d) if drawn as the winner,

(each an "Eligible Entrant").

6. If there is a dispute as to the identity of an Eligible Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Eligible Entrant.

How to enter

- 7. To enter the Promotion, the Eligible Entrant must, during the Promotion Period:
 - a) Visit the Promotion's registration page in Travel Booking via the CommBank app or NetBank and complete the registration form; and
 - b) agree to share their full name, mobile number, email address, postcode with Hopper Pty Ltd (ABN 93 008 042 699) ("Hopper") by clicking on the confirmation button on the Promotion's registration page; and
 - c) make one (1) transaction on Travel Booking of at least \$100AUD or more using their eligible CommBank retail Visa credit card, Travel Money Card or Business Visa debit card. One (1) automatic entry will be awarded per \$100 spent on a single Travel Booking. Prize Details



11. The first valid entry drawn will win a travel package for two (2) people to the Melbourne Race Weekend 2026 in Melbourne, Australia valued at up to AUD\$39,626 (depending on point of departure) ("Prize").

The Prize includes:

- a) Two (2) x return economy airfares (including airfare taxes) for the winner and their travel companion from the winner's closest Australian capital city to Melbourne, VIC, departing on 05/03/2026 and returning 09/03/2026 (only provided if winner resides outside of Victoria). If the winner is from Victoria, then the Prize does not include airfares and the airfare component of the Prize is not redeemable for cash);
- b) Four (4) x nights' twin share accommodation in a minimum 4-star hotel, including breakfast, in Melbourne between 05/03/2026 09/03/2026;
- c) Three (3) x day VIP experience for two with exclusive hospitality and track experiences between 06/03/2026 08/03/2026
- d) Return transfers from the accommodation to the Melbourne Race Weekend 2026 for two (2) people and
- e) Return airport transfer from Melbourne airport to the selected hotel.
- 12. The total Prize pool value is up to AUD\$39,626.
- 13. The Prize will be supplied and delivered by the Promoter.
- 14. During the entire duration of the prize, a nominated parent/guardian must accompany any person under 18 years of age. Companions under 18 cannot enter any areas where alcohol is served (including bars).

Determining the winner

20. The Promoter may draw additional reserve entries and record them in order in case an invalid or ineligible entrant is drawn.

Announcing and notifying the winner

- 21. The winner will be notified by CommBank via email using the contact details held by CommBank (to view these details, log on to NetBank and select 'Settings', then 'My contact details') within two (2) business days of the draw.
- 22. Notification and publication of winner details is the responsibility of CommBank. Winner details (first initial, surname and postcode) will be published online at commbank.com.au/travelbookingprizewinner from 5 February 2026. The winner



- must claim the Prize until the 8:30 AM, 17 February 2026, by confirming receipt of CommBank's notification email by return email and providing written agreement to these Terms and Conditions.

General

- the Promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 29. If for any reason this Promotion is not capable of running as planned (including, but not limited to infection by computer virus, bugs, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Promotion), the Promoter and/or CommBank may, subject to the approval of all relevant regulatory authorities, take any action that may be available including cancelling, terminating, modifying or suspending the Promotion or disqualifying any Eligible Entrant.

- 31.
