Commentary

Colonial Holding Company Limited (the Company) is the holding company for the wealth management and insurance subsidiaries of the Commonwealth Bank of Australia Group. Colonial Holding Company Limited Company and its controlled entities (the Group) is a diversified wealth management and insurance group which manages significant positions in the funds management, platforms, advice and insurance markets.

Revenue for the year of \$6,266 million (2012: \$5,043 million) is comprised primarily of insurance premium and fee revenue, investment revenue as well as fees and commissions.

The Group recorded a net profit after tax for the year ended 30 June 2013 of \$826 million (2012: \$714 million), a 16% increase on the prior year reflecting improved global investment markets and stronger investment performances in FY13.
