# CommBank Travel Money Card Visa 'Olympic Winter Games Milano Cortina 2026' Promotion 2025 ("Promotion")

#### **Full Terms and Conditions**

- The promoter is Visa AP (Australia) Pty Ltd (ABN 20 134 885 564) Level 39, International Tower 2, 200 Barangaroo Avenue, Barangaroo NSW 2000 Australia ("Promoter").
- 2. Information on how to enter and the Prize (defined below) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 3. The Promotion commences at 12.00am (AEDT) on 30 September 2025 and closes at 11:59pm (AEDT) on 11 November 2025 ("**Promotion Period"**).
- 4. The Promotion is authorised under Australian Capital Territory Permit No. TP 25/01850, New South Wales Authority No. TP/04034 and South Australia License No. T25/1390

## **Eligibility**

- 5. Entry is open to individuals who:
  - a) reside in Australia;
  - b) are aged at least 18 years of age;
  - c) hold a valid phone number and email address with the Commonwealth Bank of Australia ABN 48 123 123 124 (**CommBank**) and are eligible to receive marketing communications from CommBank at the time of the draw and when the winner is contacted. e) are able to take the following components of the Prize within the period from 14th February 2026 to 22nd February 2026 ("**Travel Period**"): flights to Milan referred to in clause 10(a); accommodation referred to in clause 10(b); tickets to events referred to in clause 10(c); transfers referred to in clause 10(d) if drawn as the winner.

(each an "Eligible Entrant").

6. If there is a dispute as to the identity of an Eligible Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Eligible Entrant.

#### How to enter

- 7. To enter the Promotion, the Eligible Entrant must, during the Promotion Period:

#### **Prize Details**

- 10. The first valid entry drawn from all valid entries received will win a trip to the Olympic Winter Games Milano Cortina 2026 for two (2) people. Prize includes:
  - a) Two (2) x economy return flights to Milan from Sydney or Melbourne, including economy return connecting domestic flights for two (2) people from the winner's nearest airport to the closest of Sydney or Melbourne (if the winner resides outside of NSW or Victoria).

- b) Six (6) x nights (15<sup>th</sup>, 16<sup>th</sup>, 17<sup>th</sup>, 18<sup>th</sup>, 19<sup>th</sup>, 20<sup>th</sup> of February 2026) hotel accommodation at min 4-star hotels (2 nights Milan & 4 nights in Livigno) in a shared room, including daily breakfast and light snacks;

- d) Airport/Train Station Transfers for two (2) people in Milan (via Motorcoach) and between Milan & Livigno and to/from Olympic events in Livigno and;
- e) AUD \$2,000 worth of Euros loaded onto the winner's CommBank Travel Money Card (the exchange rate used will be the CommBank Retail Foreign Exchange Rate at the time of the prize being awarded).

(together, the **Prize**)

- 11. The total value of the Prize is up to AUD \$32,300 depending on point of departure.

## **Determining the winner**

19. # Announcing and notifying the winner

- 20. The winner will be notified by CommBank via email using the contact details held by CommBank (to view these details, log on to NetBank and select 'Settings', then 'My contact details') within two (2) business days of the draw.
- 21. Notification and publication of winner details is the responsibility of CommBank. - 30.
